### 1. CWG Coaching Team

Tim noted that the coaches for the CWGs would be confirmed after the Canmore camp. Currently BiON doesn't have any contracts for coaching staff.

Tim also noted that it isn't clear who is covering the costs for the CWGs

**ACTION: Daniel Guay to contact Steve Jarvis, Mission staff, CWGs to clarify who is covering which costs related to the Games.**

**3. Inventory of rifles and equipment**

David provided an update on the inventory: Highlands and SSM have provided a list of what BiON rifles/equipment is at each club. David has spoken with Greg Dalton, Sudbury and has confirmed Greg has 2 S400s at his house: #s 9 & 12 – there should be 4 S400s in Sudbury. Need to determine a paper trail of what was given to Sudbury by BION.
